Dear Congressional Candidate,

**As the 2026 midterms approach, polling continues to show that immigration is a top issue.** Voters want to know where their congressional candidates stand on immigration. NumbersUSA provides an easy way for you to get this information to voters.

Over the last two decades, the news media and voters have made “Immigration Grade Cards” and “Immigration Candidate Comparison Pages” their No. 1 source for the immigration actions and the immigration positions of congressional incumbents and challengers. **Return this survey to us as soon as possible to let voters know your immigration positions.**

**NumbersUSA has more than 9 million activist members.** We begin emailing Candidate Comparison Pages to our activists early in an election year. At first, we mail monthly, and then weekly, and finally **daily just before the Primary and General elections.**

Immigration shaped the 2024 election like few other issues. For much of 2024, Gallup’s tracking found immigration at the top of Americans’ “most important problem” list – the first time the issue held that position for multiple consecutive months in over two decades of polling.

As a non-profit organization, NumbersUSA never endorses candidates. We recognize that voters mark their ballot based on many issues and judgments about the character and leadership of a candidate. What we do offer on our Grade Cards and Candidate Pages is a way for voters to know which candidates are most likely to eliminate illegal immigration and reduce legal immigration.
